6. For any claim to be considered, prior authorization must be given and alleged defective parts must be returned to JASPER for inspection.

**Buyer specifically acknowledges that the components purchased will require additional accessories/components and must be properly installed or the warranty may be void. The limited warranty will be void and not apply to defects or failures caused by (1) overrevving (2) accident, abuse or an operation for which it was not designed, or alteration, either drivetrain or suspension, from the original manufacturer's specifications (3) damaged or inefficient parts, components or accessories not included in the sale (4) dirty or improper installation (5) overheating and/or freeze cracks to blocks, heads or drive cases (6) burned or melted pistons (7) lack of lubricants or fluids (8) extensive corrosion damage to stern drive (9) detonation or preignition (10) burned thrust bearings caused by rear pressure (11) rust, corrosion or damage caused by electrolysis.**

**Buyer specifically acknowledges that proper maintenance procedures which include, but are not limited to, changing or calibrating, as applicable, the filter, lubricant, harmonic balancer, fan hub, water pump, fuel injectors, fuel pumps, hoses, belts, etc., must be performed as recommended by the original manufacturer or the warranty will be void. Camshaft timing belts must be replaced in accordance with O.E.M. recommendations. JASPER will not assume any responsibility for the cost of this routine maintenance. Failure to change this belt may lead to internal engine damage that will not be covered by the JASPER Seller Limited Warranty. BELTS, HOSES AND OTHER ACCESSORY PARTS SUPPLIED BY JASPER AS PART OF THE ASSEMBLED PRODUCT, ARE COVERED FOR THE FIRST YEAR OF THE WARRANTY ONLY. Proper installation procedures must be followed to avoid accident or injury.**

JASPER's limited warranty will end after the expiration of time or mileage from the date of the original invoice. Any repairs or replacement will not extend the warranty. The buyer shall be responsible for all defects, thereafter, regardless of cause.

JASPER's limited warranty is in lieu of all other warranties expressed or implied and **JASPER MAKES NO WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.**

**The buyer must notify JASPER of any warranty claim prior to repair for assignment of an authorization number. The work will be performed either at JASPER's factory or by another selected vendor. It is the sole responsibility of the buyer to pay for such work and, in writing, submit a claim with the alleged defective parts shipped prepaid to JASPER for its review and sole determination.**

Buyer agrees that JASPER will not be responsible for (1) incidental or consequential damages (2) lost profits, sales or income (3) injury to person or property (4) oil, antifreeze, fluids or other substances (5) towing charges (6) lift, dock or storage fees (7) telephone calls (8) freight (9) substitute transportation, lodging, etc. (10) unauthorized repairs (11) labor on a gasket kit, oil pump and lifters purchased with a short block engine or gasket kit supplied with a complete engine.

**Buyer and seller agree the seller's price is based upon this limited warranty. Buyer and seller also agree the buyer's sole and exclusive remedy against seller on account of breach of contract, warranty or performance shall be for the repair or replacement at JASPER's factory in Jasper, Indiana, of defects in JASPER's factory workmanship or material within the periods of this warranty. The buyer will be responsible for shipment and subject to the limitations and conditions of this warranty.**

No benefits or remedies are available under this limited warranty while the invoice for the unit or related services remains outstanding.

Warranty credits not used within 1 year against future purchases will be considered void.

## Jasper Premium Service Plan Details

The JASPER Premium Service Plan follows the same guidelines and time/mileage periods as the standard warranty of the product you purchased. This Premium Service Plan does not extend to any parts not covered under our standard warranty.

- JASPER's recommended installation procedures must be adhered to. Change engine oil and filter at 500 miles (or 10 hours for marine engines) and then at a suggested interval of every 3,000 - 4,000 miles or 3 - 4 months (40 hours or once a season for marine engines) whichever occurs first. Change transmission and differential fluid after 5,000 miles of highway service or 100 hours of severe use. JASPER requires lubricants meeting original equipment specifications. Use appropriate additive for limited-slip differentials.

### • EXCLUSIONS:

- Does not include vehicles used for ambulance, off-highway use, package delivery, police, racing, rented or leased, snow removal, dump truck, landscaping, taxi, tow truck, transit, motor home, industrial applications, or vehicles that have been altered in suspension or from the original manufacturer's specifications. This program excludes short block format gas and diesel engines and complete format diesel engines, as well as, gas engines, diesel engines, transmissions, transfer cases and differentials in applications larger than 1-ton.
- Does not cover repairs caused by failure of non-included parts, altered units or add-on parts. This agreement also does not cover overheating, detonation, lack of proper maintenance, wear and tear, improper installation, improper fluid levels or contamination of fluids. This agreement also does not include fire, collision, theft or other damages or casualties not associated with the remanufactured JASPER product.
- Does not provide for regular maintenance or if the vehicle's odometer has been tampered with, or for loss of use, inconvenience or other consequential loss or for any repair work not authorized by JASPER.

- This service agreement gives you specific legal rights. You may also have other rights that vary from state to state.
- If JASPER elects to replace your unit with another remanufactured unit, the replacement is considered to be a repair of the original unit and does not extend the warranty above or beyond the original date or mileage of installation.

### • TRANSFERRING:

- The service agreement is between JASPER and the customer listed on the completed form. It is transferable and should be done within 30 days of new ownership, with payment of a \$30.00 filing fee to JASPER. The agreement is still based upon the original purchase date and mileage. It may only be altered or applied by the owner listed in the agreement at that time.

## Required Initial Lubricant/Fluid Changes

To assure the long life and continued performance of your remanufactured component, we recommend that you follow the initial lubricant and fluid changes outlined below. Please follow the guidelines of the equipment manufacturer for lubricant and filter changes thereafter.

### Gasoline Engines:

Change engine oil and filter at 500 miles (or 10 hours for a marine engine) and then at a suggested interval of every 3,000-4,000 miles or 3-4 months (40 hours or once a season for a marine engine), whichever occurs first.

### Transmissions:

Change transmission fluid and filter after 5,000 miles of highway service or 100 hours of severe service.

### Diesel Engines:

Oil and filter should be changed after the first 8-10 hours of highway or commercial service.

### Differentials:

Change differential fluid after 5,000 miles of highway service or 100 hours of severe service. Requires lubricant meeting GI-5, 6 or 6 MIL. SPEC. 2105D or 2105E specifications. Use appropriate additive if limited slip version. You may be required to furnish proof of these services when making a claim.

### Stern Drives:

Change drive lubricant after first 10 hour break-in period.

### Outboard Powerheads:

Change oil & filter at 10 hours and then at a suggested interval of 100 hours or six months of service, whichever occurs first.
